Sl. No.	GENERAL CONDITIONS
1.	The total number of section of the school shall be restricted to 15 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 9 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

Sl. No.	CONDITIONS FOR COMPLIANCE
1	The total number of section of the school shall be restricted to 12, of which not more than 1/3rd sections may be used for senior secondary classes and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws subject to the availability of classrooms > 500 ft dimension.
2	The school is directed to complete the construction of remaining part of boundary wall within next 3 months and submit the compliance in SARAS Portal.
3	The school has reported that invoice for lift has been raised. The school shall install a lift for CWSN to access the upper floors of the school and submit compliance within 3 months on SARAS.
4	The school has converted regular cubicles into CWSN toilets, but they are not as per norms, being too narrow for wheel chair/walker to navigate. The urinals in boys

	washroom are on raised platform and thus inaccessible to CWSN. The school shall construct separate toilets for CWSN, boys and girls with proper access, permanent signage which shall also mention the floor number and as per norms of RPwD Act and guidelines issued by the Board and submit compliance within 3 months on SARAS.
5	The science labs are still inadequately equipped and have no storage or seating area. There are no proper work stations with utilities, only a centre table and low lying side platforms. The school shall upgrade its physics, chemistry and Biology labs as per SoPs issued by the Board and submit compliance within 3 months on SARAS.
6	The school library is under stocked and play ground is not well developed. The school shall upgrade its sports facilities and library as per SoPs issued by the Board and submit compliance on SARAS within 3 months.
7	The school is directed not to remove the mandatory disclosure section from its website and the videography link of the inspection /infrastructure from YouTube.
8	The school shall conduct training of its teachers with CoE Chandigarh within 3 months and submit the compliance on SARAS.
9	The school shall get all the mandatory certificates renewed periodically.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.


